3	Brief description of scheme	<p>Establishing a capital budget to carry out major repair works to retaining walls which are the responsibility of the Council.</p> <p>The Council is the owner of a number of retaining walls located on non-operational Council owned land and has in many instances been made contractually responsible for maintenance. (Maintenance of highways and operational property related walls are managed through relevant portfolio arrangements).</p> <p>There is a pressing need to undertake remedial and repair works to the condition of the Blast Furnace Wall at the 45 Yard, Steelworks Road, Ebbw Vale.</p> <p>The works required would be of a health and safety related nature and are more than routine maintenance.</p> <p>The Council established a retaining wall reserve (revenue funding) a number of years ago to meet unforeseen costs with maintenance of Council retaining walls. This reserve has been allocated to deal with a retaining wall issue in Brynmawr and is therefore not available.</p>

8	<p>Is the scheme an existing legal/contractual commitment</p>	<p>As mentioned above, the Council is the owner of a number of retaining walls located on non-operational Council owned land and has been made contractually responsible for maintenance in many instances.</p> <p>When the Council acquired land at Cwm Draw, from the then British Steel Corporation, it was made contractually responsible for the ownership and maintenance of the blast furnace wall located at the former 45 Yard, Steelworks Road, Ebbw Vale.</p>
9	<p>Is there any external grant aid or any other funding such as prudential available to fund the project? Are there any similar schemes across the Authority utilising other funding sources?</p>	<p>There are limited if any opportunities as the walls are the legal responsibility of the Council.</p> <p>CADW may well be able to allocate funds to assist with works to the 45 Yard and this will be explored with relevant Officers at CADW.</p> <p>Where funding has been available historically for e.g. regeneration schemes the Council has often been successful in incorporating works to retaining walls in those schemes, therefore mitigating risk and cost.</p>
